SEPSIS AWARENESS

Sepsis Alliance's main focus is on raising awareness of sepsis so that treatment can be sought and provided quickly. Each year the organization fields a national awareness survey. In 2007 (the year of the organization's founding) national awareness was at just 19%. In 2018, that number had risen significantly to 65% of US adults that have heard of sepsis.

SEPSIS HEROES CELEBRATION

As a focus of Sepsis Awareness Month, Sepsis Alliance hosted its 7th Sepsis Heroes Celebration event on September 13, in New York City, to celebrate the achievements of individuals and organizations who are making a difference in the fight to raise sepsis awareness and save lives. This year's event recognized Jay Towers, radio and TV personality; UM-PULSE, a patient recovery clinic; Rooks County Health Center, and sepsis advocates Jill Blake and Sharon Hansen. Also recognized was Angelica Hale, America's Got Talent runner up and sepsis survivor. The event was our largest and most successful to date, and was held at Marquee in NYC.
